**Regular Board Meeting Wednesday, February 18, 2026 7:00 pm**

**Call to Order.** The meeting was called to order by Chair Klein at 7:00 pm

**Request for support – Village of Trempealeau Police Station.** Reviewed a request received from the Village of Trempealeau, asking for a letter of support for a grant they are writing for funds for a new village police station. **Road Project Planning.** Wright Road will be completed with LRIP funds, Hold on Meunier for 2026, Finish McGilvary to Sawmill with co-aid funds. Use balance of LRIP funds on Hollow Lane.

**Zoning Change Policy.** Discussion for consistency going forward. The board will request a map/visual identifying the location of the building (if applicable) and the lot. The clerk will mail letters to adjoining landowners asking for input.
