Call to Order. The meeting was called to order by Chair Klein at 7:00 pm

Motion to approve the rezone request of parcels 008-00337-0005 and 008-00346-0000 by Supervisor McDonah, seconded by Supervisor Mahutga. Motion carried.

Authorized Signers – Co-op Credit Union. Discussed the authorized signers for the Co-op Credit Union. Motion by Supervisor Mahutga to remove Geoff Stetzer & Blaise Stegemeyer and add Stacey Klein and Sarah Halderson as signers on the account, seconded by Chair Klein. Motion carried.
